The Hill Apartments are closing due to their condition and the cost to maintain. Beginning in Fall 2024, no new residents will be allowed to live there; however, five families, two graduate assistants, and three undergraduate students will be living in Hill Apartments in Fall 2024. All assignments will be consolidated to the least number of units. The sunsetting of the apartments does not include the units utilized by the Commercial Aviation Department.
